**FINES/COSTS MUST BE PAID, OR A HEARING SCHEDULED, WITHIN TEN (10) CALENDAR DAYS OF THE DATE OF THE TICKET OR BEFORE ANY SPECIFIC COURT DATE NOTED ON THE TICKET.**

An additional \$35.00 judgment fee will be added after that time for failing to respond to the citation. This will result in the suspension of driving privileges and an additional \$45.00 clearance fee. Fines and fees not paid within 56 days of that date are subject to a 20% penalty. If a fine is not listed below, please call the court for assessments.

If paid after 10 days.....\$ 20.00  
(20% percent penalty applies after 56 days)

All other parking violations..... \$ 50.00  
(Add \$10.00 to all parking violations paid after hearing date)

Violations may be cleared without fines/costs (Exception – no proof of insurance) by correction of the violation/valid proof and presenting the violation(s) to any law enforcement officer to certify the correction/valid proof. **THE TICKET MUST BE RETURNED TO THE GROSSE POINTE MUNICIPAL COURT WITHIN TEN (10) DAYS OF THE ISSUE DATE ON THE VIOLATION.**
